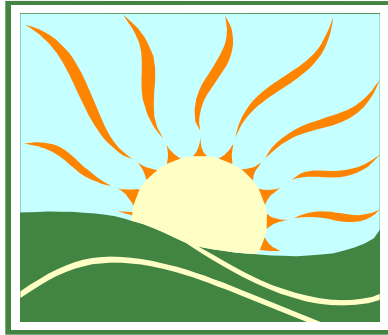


Nebraska Farm Bureau Young Farmers & Ranchers Greater Horizon Scholarship Application



Nebraska Farm Bureau Federation will award at least one \$1,000 scholarship per year with the possibility of two being awarded.

ELIGIBILITY CRITERIA

1. Must belong to a member family of a county Farm Bureau in Nebraska or have own membership.
2. Must be a resident of Nebraska.
3. Must have intention of enrolling full-time in a college or university's agricultural field of studies and returning to farming or ranching.
4. Must have completed application postmarked by May 1st.
5. Demonstrated leadership potential through extracurricular activities and work experience.
6. Must provide three letters of reference (other than family).
7. Must be 18-35 years of age.
8. Must provide a copy of most recent transcript.
